Business dynamics

Establishments

Between March 2020 and March 2021, 16,607 Indiana establishments opened and 12,378 closed, for a net increase of 4,229. Employment expanded at 34,055 establishments and contracted at 42,525. Small businesses accounted for 15,441 openings and 11,275 closings.

Employment

Opening and expanding Indiana establishments added 248,183 jobs, while closing and contracting establishments lost 300,815, for a net decrease of 52,632 jobs. Small businesses gained 164,763 jobs and lost 189,214, for a net decrease of 24,451 jobs.

Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2020, reporting banks issued \$1.9 billion in loans to Indiana businesses with revenues of \$1 million or less.
