Employer and employment dynamics

Establishments

Between March 2023 and March 2024, 4,609 establishments opened and 4,813 closed, for a net decrease of 204. Employment expanded at 9,209 establishments and contracted at 9,509. Small businesses accounted for 4,265 establishment openings and 4,454 closings.

Employment

Opening and expanding Hawaii establishments added 51,978 jobs, while closing and contracting establishments lost 50,170, for a net increase of 1,808 jobs. Small businesses contributed a net increase of 129 jobs, or 7.1 percent of that total.

Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2023, reporting banks issued \$350.5 million in loans to Hawaii businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$1 million or less was \$1.1 billion. Total reported new lending to businesses through loans of \$100,000 or less was \$495.2 million. A total of 677 identified firms exported goods worth \$341.0 million from Hawaii in 2022. Of those exporters, 586—or 86.6 percent—were small.
