### Employer and employment dynamics

#### **Establishments**

Between March 2023 and March 2024, 35,143 Illinois establishments opened and 34,914 closed, for a net increase of 229. Employment expanded at 70,006 establishments and contracted at 67,289. Small businesses accounted for 33,940 openings and for 33,376 closings.

#### Employment

Opening and expanding Illinois establishments added 449,958 jobs, while closing and contracting establishments lost 459,493, for a net decrease of 9,535 jobs. Small businesses gained 323,299 jobs and lost 309,168, for a net increase of 14,131 jobs. Thousands of establishments

#### Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2023, reporting banks issued \$3.3 billion in loans to Illinois businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$1 million or less was \$10.1 billion. Total reported new lending to businesses through loans of \$100,000 or less was \$3.6 billion. #### Small business exports

A total of 21,929 identified firms exported goods worth \$73.4 billion from Illinois in 2023. Of those exporters, 19,462—or 88.8 percent—were small.
