Employer and employment dynamics

Establishments

Between March 2023 and March 2024, 11,181 establishments opened and 9,865 closed, for a net increase of 1,316. Employment expanded at 19,681 establishments and contracted at 18,828. Small businesses accounted for 10,314 establishment openings and 9,076 closings.

Employment

Opening and expanding Kansas establishments added 123,210 jobs, while closing and contracting establishments lost 117,566, for a net increase of 5,644 jobs. Small businesses gained 90,943 jobs and lost 80,342, for a net increase of 10,601 jobs. Thousands of establishments

Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2023, reporting banks issued \$633.6 million in loans to Kansas businesses with revenues of \$1 million or less.
