# **New York**

#### Employer and employment dynamics

#### **Establishments**

Between March 2023 and March 2024, 66,875 New York establishments opened and 64,442 closed, for a net increase of 2,433. Employment expanded at 121,211 establishments and contracted at 118,131. Small businesses accounted for 62,612 openings and 59,915 closings.

#### Employment

Opening and expanding New York establishments added 880,875 jobs, while closing and contracting establishments lost 752,356, for a net increase of 128,519 jobs. Small businesses contributed a net increase of 54,510 jobs, or 42.4 percent of that total.

### Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2023, reporting banks issued \$5.0 billion in loans to New York businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$1 million or less was \$14.7 billion. Total reported new lending to businesses through loans of \$100,000 or less was \$7.7 billion. A total of 32,079 identified firms exported goods worth \$80.3 billion from New York in 2023. Of those exporters, 29,808—or 92.9 percent—were small.
