


Employer and employment dynamics

Establishments

Between March 2023 and March 2024, 5,385 Rhode Island establishments opened and 4,854 closed, for a net increase of 531. Employment expanded at 8,197 establishments and contracted at 7,355. Small businesses accounted for 5,144 openings and for 4,644 closings.

Employment

Opening and expanding Rhode Island establishments added 45,194 jobs, while closing and contracting establishments lost 40,056, for a net increase of 5,138 jobs. Small businesses contributed a net increase of 4,102 jobs, or 79.8 percent of that total.

Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2023, reporting banks issued \$228.4 million in loans to Rhode Island businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$1 million or less was \$689.8 million. Total reported new lending to businesses through loans of \$100,000 or less was \$306.9 million. 

A total of 2,020 identified firms exported goods worth \$2.8 billion from Rhode Island in 2023. Of those exporters, 1,770—or 87.6 percent—were small. 
